KeyValueData and BVDataWorld Subscription Terms and Conditions

This section sets forth the Terms and Conditions ("Agreement") under which you may use the KeyValueData.com and BVDataWorld.com paid services ("Subscription"). If you do not accept the Terms and Conditions stated here, do not purchase a subscription to KeyValueData.com/BVDataWorld.com. By purchasing a subscription and logging in to KeyValueData.com/BVDataWorld.com you acknowledge that you have read and agree to abide by these Terms and Conditions.

Section 1. Terminology

- a. Subscriber: A subscriber is a natural person who has purchased a subscription to KeyValueData.com/BVDataWorld.com within 365 days of the present date. Each subscriber is provided with a unique login ID and password for their personal use.
